## Dr. Ahava Wins His Apeal Saves \$64,000 in Fees

On September 29, Judge Ronald Johnson of the 19th Judicial District Court, reversed the state psychology board's 2015 decision to revoke Dr. Glenn Ahava's license and granted his appeal. The reversal nullifies almost \$64,000 in fees that the board had intended to charge Dr. Ahava for his prosecution.

In the order, Judge Johnson said that the state psychology board had failed to meet certain legal standards in investigation and prosecuting of Dr. Glenn Ahava. Because of violations of the time limit for an investigation, and also a failure to properly notify Dr. Ahava of certain matters, Judge Johnson reversed the board's decision to revoke Dr. Ahava's license and granted his appeal.

## Dr. Ahava Wins His Apeal Saves \$64,000 in Fees, continued

Dr. Ahava, a forensic psychologist at the time, had two complaints about his reports to the court, and one complaint about a billing dispute. In 2015, the board revoked his license but Dr. Ahava immediately appealed the decision. In 2019, Judge Janis Clark found in favor of Ahava on two counts but delayed a third issue regarding the billing dispute.

On September 29, 2023, Judge Johnson ruled that the board was "in violation of Louisiana revised statute section 37:2353, which provided in 2015 that "no disciplinary proceedings shall be commenced more than one year after the date upon which the board knows or should know of the act or omission upon which the disciplinary action is based."

Because Dr. Ahava has won his appeal, he does not have to pay the \$63,952.29 billed him by the board.

According to the board's documents, the fees that would have been charged to Dr. Ahava included \$43,525.49 for prosecuting attorney Jim Raines. Also fees included \$8052.50 charged by attorney Amy Groves Lowe. Charges for the administrative law judge fee totaled \$5500.50 and the court reporter was \$1178.

Board members were charged at \$750 to attend which came to \$3750. Mileage was \$295.80.

Hotel rooms for Kelly Parker and Tony McCoy total of \$1000. Gary Pettigrew is reported to have a fee of \$350. Room rental was \$300.

In 2015, the time limit became an issue in a complaint case against forensic psychologist Dr. Alicia Pellegrin. [See "LSBEP Attorneys in Damage Control Mode? Investigations Committee May Have Botched Time Limits on Complaints," (Times Vol. 6, No. 10)]

Dr. Pellegrin explained that she had been investigated by the board for three years, with the main criticism that she had acted improperly when she decided not to disclose her professional identity to a seven-year old whom she was evaluating by court order.

During her hearing, the board's legal team persuaded the complaints coordinator to drop the charges against Pellegrin, following an executive session and the recommendation of the attorney regarding the problematic time limit issue.

In 2017, the Board sponsored Senate Bill 37 which deleted the one—year time limit language. That language had originally been crafted by Dr. Jim Quillin. The bill also added provisions for fees in disciplinary actions.

"The board may charge a hearing fee to include reasonable costs and fees incurred by the board for the hearing or proceedings, including its legal fees, stenographer, investigator, staff, and witness fees and any such costs and fees incurred by the board on any judicial review or appeal," and

"The board may charge an informal resolution fee to include reasonable costs and fees incurred by the board for a disciplinary action that is resolved by settlement, consent decree, or other informal resolution, including its legal fees, stenographer, investigator, staff, and witness fees."

Some in the community consider the board to have been overzealous beginning in 2014 with attorney fees skyrocketing in the years following.

According to Boards and Commission budget tracking the psychology board projected a fund balance of minus \$400,595 for 2018.

This came after several years of over–budget spending that appears to be due in large part to legal fees. The psychology board is self-funded, and it operates with income supported by license fees and other service fees.

Based on the budget and financial tracking provided at the Boards & Commissions website, the LSBEP stayed approximately within budget for most years and carried a "fund balance" of around \$100,000, which appears to function as a savings reserve. Increased legal spending paralleled a change in the design of the complaints committee and additional attorney employees.

Through key priority areas of collaboration, awareness, workforce, prevention, and healing, WHL envisions a Louisiana in which children, families and communities are healthy and thriving regardless of who they are or where they live.

"The Louisiana Department of Health is extremely proud to have partnered on this effort to develop a comprehensive approach to preventing and addressing trauma across child-serving systems. We remain committed to working with our partners from across the state to support the implementation of the Whole Health Louisiana State Plan. Building on the community input we have gathered, we will continue to integrate the healing-centered and trauma-informed objectives outlined in this plan within our agency and provide support to other state agencies, organizations and communities that are working to do the same," LDH Deputy Secretary Tonya Joiner said.

Two years ago, LDH, the Louisiana First Foundation and leaders across the state formed the WHL initiative to prepare Louisiana to better respond to the drivers and impacts of childhood adversity by developing a comprehensive plan. The WHL State Plan is built upon the initial discovery phase, which took place from

September 2021 through August 2022. During the plan development phase, public sector leaders, community members, advocates, and child- and family-serving workforce representatives came together to create a traumainformed statewide plan with sector-specific strategies, implementation and evaluation approaches with buy-in across systems. WHL is the only coalition in the state uniting all child and family-serving entities across sectors and populations.

"Through our work to raise awareness about the science of childhood adversity, trauma and resilience, the Bureau of Family Health (BFH) was asked to coordinate the development of the WHL State Plan on behalf of the Department.

"For us, it was both an honor and a timely call to come together with our partners from all regions of the state to create a plan to provide families, communities and service providers with a toolkit to prevent and address these issues.

"Our mission at BFH is to elevate the strengths and voices of individuals, families and communities to catalyze transformational change to improve population health and achieve equity. We believe that the WHL State Plan moves us all closer to achieving that mission and are happy to continue to support the initiative through its implementation," said Amy Zapata, Bureau of Family Health director.

Over the next five years, LDH will continue to foster public and private

sector partnerships to implement and sustain the plan for the long term. Becoming trauma-informed requires education, training, and ongoing self-reflection for all involved.

By being trauma-informed, individuals and communities can play a vital role in creating spaces that promote healing, resilience, and recovery for those who have experienced trauma.

"To that end, the Department will be supporting the implementation of the State Plan over the first five years with both funding and dedicated staff support to ensure a successful transition from planning to implementation," Joiner said.

The success of this plan lies in all of our hands and within each community across our state. If you are just learning about this work, we invite you to join us. If you have supported the development of this initiative in any way, we thank you and look forward to continuing this work together," Joiner said.

Plan objectives will be implemented from January 2024 to December 2028, establishing structures, policies and practices to propel Louisiana toward our vision of healthy and thriving children, families and community members, regardless of who they are or where they live.





## Stress Solutions

### Chronic Stress Can Harm Your DNA

Most everyone over 30 is concerned with aging and agerelated illnesses, like cancer and heart disease. The role of stress and cortisol in aging and chronic illness is now well established. But how increased cortisol is linked to early aging has not been clear...until very recently. Scientists at the U. of California, San Francisco have been working for a decade on the links in this chain. And, the answer is: short telomeres.

Telomeres function like a cap whose job it is to protect the end of the chromosome where the genes lie. Each time the cell divides, a bit of the telomere is cut off (instead of the gene). Dr. Elizabeth Blackburn, a molecular biologist now at UCSF, won the Nobel Prize in 2009 for her discovery of how chromosomes and genes are protected. Over time, with repeated reproduction, the telomere gets shorter. As the telomere becomes shorter, the organism begins to age and irregularities creep into the reproduction process. Some cancers may be due to these irregularities. Dr. Blackburn's discovery was that the telomeres are actually replenished by an enzyme, telomerase reverse transcriptase.

The bad news, however, is that stress and excess cortisol damage the body's supply of telomerase. So chronic stress can cause premature aging and illness because the constant overproduction of cortisol reduces the supply of telomerase and that prevents the cell from reversing the effects of stress. Telomere length (TL) can now be measured. However, if you are the President of the US, one does not need fancy tests to measure your TL. Stress is not the only way that telomeres become short too soon. Some people have the bad luck to be born with shorter telomeres. Others earn shorter telomeres in advance of their years by their life style choices. And, some have been exposed to early life adversities, which lead to shorter TLs over time.

Dr. Susan Andrews is a Clinical Neuropsychologist, an award-winning writer/author (her book Stress Solutions for Pregnant Moms, published in 2013, has been translated into Chinese,) and 2016 Distinguished Psychologist of the Louisiana Psychological Association.

The same scientists that discovered telomerase have been working on finding solutions to the harmful effects of chronic stress on DNA. In 2010, Dr. Puterman and colleagues demonstrated that moderate to vigorous physical exercise can buffer the effect of chronic stress on TL. Subjects took the Perceived Stress Scale and were divided into sedentary (not exercising) versus the active group (those getting the CDC recommended amount of daily exercise). The likelihood of having short versus long telomeres was calculated as a function of stress and exercise group, covarying age, BMI, and education. There was a significant moderating effect of exercise. Non-exercisers with even a one unit increase on the Perceived Stress Scale showed a 15-fold increase in the odds of having short telomeres, whereas for the exercisers, perceived stress was unrelated to telomere length. The conclusion is that "vigorous physical activity" (increased HR, sweating, +/or rapid breathing) appears to protect people experiencing high stress.

The USDA recommends that adults (18 to 64) do at least 2 hours, 30 minutes each week of moderate physical activity (brisk walking, dancing) OR 1 hour, 15 minutes each week of aerobic physical activity at a vigorous level (running, walking fast uphill, cycling). Being active 5 hours or more a week can provide even more health benefits. It is recommended that the physical activity be spread out over at least 3 days a week and that each activity should last at least 10 minutes at a time. Strengthening exercises are also recommended, like sit ups, weights, at least 2 days a week to maintain memory.

In sum, as you age, it is essential to protect your telomere length by a minimum of 25 minutes at least 3 days a week of vigorous exercise. Next month we are hopefully holding onto our New Year's Resolutions. I hope one of yours is to do 25 minutes of vigorous exercise at least 3 days a week! Happy New Year!


